9 **INTRODUCTION**

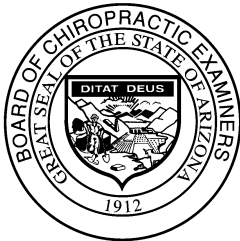
10 Pursuant to A.R.S. § 32-924(E), the State of Arizona Board of Chiropractic Examiners
11 (“Board”) held an Initial Appearance for Bruce D. Homsey, D.C. on January 10, 2018.
12 Respondent knowingly and voluntarily appeared before the Board, and was represented by legal
13 counsel. Respondent was properly notified of the Initial Appearance and the allegations against
14 him. After due consideration and deliberation of the facts and law applicable to this matter, the
15 Board voted to issue a Non-Disciplinary Order for Continuing Education.

16 **FINDINGS OF FACT**

- 17 1. The Board is the duly constituted authority for the regulation and control of the
18 practice of chiropractic in the State of Arizona.
- 19 2. Respondent is the holder of License No. 4708 to practice chiropractic in the State of
20 Arizona.
- 21 3. Board staff’s investigation revealed that the dates of treatment that
22 Respondent documented in his patients’ notes did not always match the dates indicated in
23 those patients’ billing records.
- 24 4. Board staff’s investigation revealed a misuse of modifier 25 in conjunction
25 with CPT code 99202 without corresponding documentation in the patient’s records.
- 26 5. Board staff’s investigation revealed a misuse of modifier 59 in conjunction
27 with CPT code 97140 without corresponding documentation in the patient’s records.
