A.R.S. § 38-431.03 (A)(2). Executive Sessions are not open to the public.

The Board usually allows 5 minutes per person for public comment on any agenda item, however, depending on the issue presented, the Board Chairperson has the discretion to expand that time.

The Board reserves the right to change the order of items on the Agenda or to take action on any item and call cases in random order.
