In addition; while the scope of practice for a chiropractic physician in the State of Arizona allows for nutritional counseling, the Board has stated for the record and reminded licensees they can treat a patient with diabetes, however they cannot *treat* the patient's diabetes. The same applies to many other conditions such as cancer, thyroid disorders and multiple sclerosis just to name a few. Whenever treating a patient with a condition that may fall outside the scope of chiropractic, it is advisable to do so under comanagement with their primary care physician.

As new developments in treatment for a multitude of conditions continue to emerge and the comanagement of patients becomes ever more important, the Board urges you to think twice before advertising for or entering a treatment regimen.

Often in these matters the Board hears from licensees that they purchased the advertising materials, simply added their name and began distributing/publishing the information. Much to their dismay, the licensee had to be reminded this is not an adequate defense.

Please keep in mind, it is YOUR advertising and you are responsible to ensure it is not false or misleading in any manner; that is does not claim professional superiority over other chiropractic physicians or other forms of treatment; that the treatment you provide falls within the scope of chiropractic and that it is clearly evident the treatment is being offered by a chiropractic physician. The Board cannot discipline the marketing company selling the advertising, the website developer or printing company creating the advertising on your behalf - it can discipline your license.

A.A.C. R4-7-902 (26). Claiming professional superiority in the practice of chiropractic under A.R.S. § 32-925.

CE Record Keeping Requirement

Beginning in calendar year 2014 (between January 1, 2014 and December 31, 2014) and in every evennumbered calendar year thereafter, you will be required to complete two hours of continuing education in record keeping to be eligible for license renewal and to

course, please keep in mind that billing and coding is not the same as recordkeeping. If you take a billing and coding course, it will not meet the record keeping requirement or qualify for continuing education credit toward your license renewal. A list of all of the courses that have been approved by the Board is posted on our website and there are several courses that may be

Courses with Pending Applications or Approvals may not receive Approval from the Board. Ensure that the courses you wish to take meet the requirements and have approval prior to registration.

While you are not required to complete a specific record keeping course to fulfill this requirement, the course you choose must meet the continuing education requirements set forth in statute and rule to qualify for credit. When choosing a record keeping

Please note that the two hour record keeping requirement is not in addition to, but part of the twelve hours of continuing education you are required to complete annually. The remaining ten hours of continuing education you must complete may be in record keeping, but you may only apply the

Change of Address

All licensees are required by law to keep their addresses and telephone numbers current with the Board. Those who fail to notify the Board of a change in their mailing, office or home address or their office or home telephone number in writing within 30 days of the change are subject to a \$50.00 penalty.

To assist in making the notification of your address change to the Board easier, there is a form available on the Board website at www.chiroboard.az.gov/about-us/forms You may submit your change to the Board by mail, fax or email.

Chiropractic Assistants

The Board wishes to gently remind the profession that the Board must be notified of the employment of Chiropractic Assistants within seven calendar days of the date the Chiropractic Assistant began physically working with patients.

The Chiropractic Assistant Notice of Employment is available on the Board Website under Forms. The form maybe submitted by fax, email or mail.

WHAT is a Business Entity?

As you are likely aware, the Chiropractic Act now requires Business Entities to register with the Board and to renew that registration on an annual basis. These new laws and rules give the Board jurisdiction over the Business Entity in a continued effort to protect the health, safety and welfare of the public.

The definition of a Business Entity is only "slightly" confusing, said as simply as possible.....

A Business Entity is any entity (sole proprietorship, corporation, clinic, franchise, business, club, LLC, or LLP) providing chiropractic services that is owned by any individual who is NOT an Arizona

licensed healthcare professional.

If the entity is owned IN ANY PART by an Arizona licensed healthcare professional, it is NOT a "Business Entity" and does not have to register with the Board as a "Business Entity".

A Year in Review

In Fiscal Year 2014 the Board had a total of 2544 Licensees. The Board issued 70 new Licenses, 56 New PMMTP Certificates and 11 New Acupuncture Certificates.

The Board received 95 complaints and adjudicated 118 complaints in total. 49 complaints were dismissed while 53 received a Non-Disciplinary Advisory Letter.

16 complaints resulted in a Disciplinary Action.

Board Staff received 298 Notice of Chiropractic Assistant Employment Forms and registered 236 Chiropractic Assistants.


